C. RIGHTS OF THE DATA SUBJECT UNDER ARTICLE 11 OF LAW NO. 6698

You may submit your requests regarding your personal data by filling out the Data Subject Application Form and choosing one of the following methods:

- Sending it with a wet signature and a copy of your ID to the address: Mecidiye Mahalle, Tayyareci Fevzi Sokak, No: 1 – 3 Ortaköy, İstanbul/Türkiye,
- Applying in person to the Abiteks office at Mecidiye Mahalle, Tayyareci Fevzi Sokak, No: 1 – 3 Ortaköy, İstanbul/Türkiyewith a valid ID,
- Signing the form with a mobile signature or secure electronic signature and sending it to the dedicated email address for KVKK [aykut.yilmaz@abiteks.com.tr],
- Sending it to the company’s registered electronic mail (KEP) address using a registered electronic mail (KEP) account, secure electronic signature, or mobile signature [],
- Sending it from your email address registered in the Abiteks system to the email address dedicated to KVKK [abiteks@hs03.kep.tr].

In accordance with the Communiqué on the Procedures and Principles of Application to the Data Controller, the Data Subject must include their name, surname, signature if the application is in writing, Turkish Republic ID number (or passport number if the applicant is a foreigner), address for notification, email address, phone number, and fax number, if any, and information regarding the request.

When making an application to exercise the rights mentioned above, the Data Subject should clearly and understandably state the specific right they wish to exercise. Any relevant information and documentation should also be attached to the application.

The request must pertain to the individual making the request; if acting on behalf of someone else, the applicant must be specifically authorized in this regard, and proof of this authorization (power of attorney) should be provided. Additionally, the application must include identity and address information and supporting identity verification documents.

Requests made by unauthorized third parties on behalf of someone else will not be considered.

Your requests related to your personal data will be evaluated and responded to within 30 days at the latest, starting from the date we receive them. If your application is denied, the reasons for the refusal will be communicated to you via email, postal mail, or the method of your request, if possible.
